Take exit 228 for OR-34 toward Lebanon/Corvallis (0.3 mi). Turn right onto OR-34 W/Corvallis-Lebanon Hwy (9.6 mi). Use the left 2 lanes to turn left onto OR-34 (0.7 mi). Merge onto OR-99W S/SW 3rd street 4th St/Pacific Hwy W via ramp to Junction City/S. Corvallis. Continue to follow OR-99W S/SW 3rd St/Pacific Hwy W. Destination will be on the right

Use middle lane to continue on Pacific Blvd SE (0.3 mi). Use right lane to turn right onto US-20 ramp to City Ctr/Corvallis (0.2 mi). Use any lane to turn right onto US-20 W/SE Lyon St (0.7 mi). Turn right onto NW Springhill Drive (0.2 mi). Turn left onto NW Hickory St (0.3 mi) and follow road to building.
